# Decision on the tow-away of a vehicle to a warehouse and the obligation of the owner to compensate for the towing costs, Orimattila

## 8 Costs of towing the vehicle

The owner of the vehicle is obliged to compensate the Centre for Economic Development, Transport and the Environment for any costs incurred in the organisation and administration of the vehicle's tow-away and the towing itself (Section 11 of the Act on the Tow-away of Vehicles).

Additionally, the Act on the Tow-away of Vehicles contains provisions on the obligation of the owner of the vehicle to compensate the municipality for the costs incurred from storing the vehicle. The compensation is determined according to a rate approved by the municipal authority (Section 11 of the Act on the Tow-away of Vehicles). The owner of the vehicle must themselves determine how to pay the compensation to the municipality.

### 10 Payment and collection of the invoice

The invoice will be sent separately by mail within two weeks. You must pay the vehicle's tow-away costs to the bank account specified in the invoice no later than the due date. You may request a revision of this invoice from the Lapland Centre for Economic Development, Transport and the Environment. The Centre for Economic Development, Transport and the Environment has the right to collect unpaid compensation by enforcement.

### 11 Retrieving the vehicle from the warehouse

The vehicle must be retrieved from the warehouse within 30 days of receiving a notification of this decision, or the ownership of the vehicle will be transferred to the municipality as laid down in Section 13 of the Act (Section 10 of the Act on the Tow-away of Vehicles).

When retrieving the vehicle, you must demonstrate that the costs of towing the vehicle have been paid. The municipality is not obliged to hand over the vehicle from the warehouse before the invoice of the Centre for Economic Development, Transport and the Environment and the municipality's storage costs have been paid (Section 12 of the Act on the Tow-away of Vehicles).
